

Features of conducting entrance tests for people with disabilities and persons With limited opportunities health

At carrying out introductory tests For incoming from number of disabled people and persons with limited opportunities health (Further – incoming With limited opportunities health) University provides Creation conditions With taking into account features psychophysical development applicants their individual opportunities And state health (Further respectively – special conditions, individual peculiarities).

During in-person entrance examinations in University secured unhindered access incoming With limited health facilities in the classroom, toilets and other premises, as well as their stay V specified premises (V volume number Availability ramps, lifts, handrails, widened doorways, auditorium for delivery entrance test is located on ground floor building).

Full-time entrance examinations for applicants with disabilities opportunities health are held in separate audience.

Number incoming With limited opportunities health V one audience Not must exceed:

- at surrender introductory tests V written form - 12 Human;
- at surrender entrance test V oral form – 6 Human.

Allowed presence V audience in time delivery introductory tests more numbers incoming With limited opportunities health, as well as conducting entrance tests for applicants with limited opportunities health V one audience together With other applicants, if this does not create difficulties for applicants when surrender introductory tests.

Allowed presence V audience in time delivery introductory testing an assistant from among the organization's employees or attracted persons, providing incoming With limited opportunities health necessary technical assistance taking into account their individual characteristics (take a workplace, move around, read and complete assignments, communicate With persons conductive introductory trial).

Duration of the entrance test for applicants from limited opportunities health, By their written request, presented V reception commission University, increases By decision of the executive secretary of the selection committee, but not more than 90 minutes. For applicants With limited opportunities health information on the procedure for conducting entrance examinations.

Admissions With limited opportunities health can V process delivery introductory tests enjoy technical means necessary them V communications With their individual features.

At carrying out introductory tests provided performance the following additional requirements (V dependencies from individual characteristics of applicants with disabilities health):

1. For blind:
 - assignments to be completed during the entrance test are completed in form electronic document, affordable With with help computer with specialized software providing For blind or are read out assistant;

- written tasks are being carried out on computer with specialized software providing For blind or dictated assistant;
- at face-to-face carrying out introductory tests incoming For execution tasks at necessity provided set written accessories And paper For letters relief-point in Braille or a computer with specialized softwareproviding for the blind;

2. For visually impaired at face-to-face carrying out introductory tests:

- provided individual uniform lighting Not less 300 luxury;
- arriving to complete a task if necessary provided increasing device, Maybe Also usageown increasing devices;
- tasks to complete, as well as instructions on how to carry out entrance examinations are issued enlarged font;
- for the deaf and hard of hearing during in-person admissions tests:
- the availability of sound amplification equipment for the collective is ensured use, at necessity incoming provided – sound-amplifying equipment individual use (at face-to-face carrying out introductory tests);
- are provided services sign language interpreter;

3. For deaf-blind are provided services sign language interpreter (besides requirements, carried out respectively For blind and deaf);

4. For persons With heavy violations speeches, deaf, hearing impaired introductory tests, carried out V oral form, are carried out V written form; for persons with musculoskeletal disorders, disorders motor functions upper limbs or lack of upper limbs:

- written tasks dictated assistant;
- introductory tests, carried out V written form, are carried out V oral form.
